The suggested alternative route is shown on the accompanying plan (Drawing NO. 3/1/21/H41 between points G-A-C-H. The footpaths were previously subject to a Stopping Up Order in 2013. That Order has now expired and the paths are currently closed by a Temporary Prohibition of Traffic Order made under the Road Traffic Regulation Act 1984, but Sibelco UK have again applied under the Town &



Country Planning Act 1990 to temporarily stop up the footpaths for the duration of the operations for the extraction of silica sand north west of Brewer Street Farm, for which planning permission has been granted by Surrey County Council (SCC ref: 2020/434 & RE20/00463/CON.)
